Dear Prime Minister,

We write to you as former Canadian Ambassadors, High Commissioners and Consuls General who proudly worked to promote longstanding Canadian values and interests in a world order that respected international law and the rights and the dignity of all peoples. We are deeply concerned that these precepts are being abandoned daily with the massive displacement, indiscriminate bombardment and starvation of Palestinian civilians in Gaza and the violent attacks by extremist settlers in the West Bank.

We understand the profound impact that the brutal and criminal acts committed by Hamas militants on October 7, 2023, have had on Israeli families and society and we strongly support the safe and immediate release of all the hostages. Canada has always been a steadfast supporter of the State of Israel. However, this cannot include a dispensation to forsake its responsibilities under International Humanitarian Law to protect civilians. If Israel continues on this path, it will lose its standing with the world community, placing the security and the future of the Israeli people in jeopardy. We firmly believe that the security of Israelis and Palestinians can only be sustained through a permanent political settlement and that can only start with an immediate ceasefire.

On July 21st Minister Anand stood with 24 other foreign ministers to demand that Israel "comply with its obligations under International Humanitarian Law" to protect civilians. In the face of an imminent famine, the Israeli government has made some small but insufficient concessions to increase aid flows while continuing to bomb and kill civilians. Prime Minister, we fully support your statement of July 25th that "the denial of humanitarian aid is a violation of international law" and that "Israel's control of aid distribution must be replaced by the comprehensive provision of humanitarian

assistance led by international organizations". These are strong words, that need to be supported by strong actions.

To exert additional pressure on both Israel and Hamas to finalize a ceasefire, bring the hostages home safely, ensure international humanitarian organizations are given full access to deliver assistance and that all civilians are afforded their rights and protections under International Humanitarian Law we propose that:

- Canada continue to refuse to channel aid through the Gaza Humanitarian
 Foundation or dangerous air drops, and insist that Israel allow full and protected
 access on a sustained basis to international and UN agencies, including UNRWA,
 for the delivery of humanitarian assistance through existing road networks;
- 2. Canada join with other UN member states to demand action by the UN Security Council and, in the event of a veto, seek an Emergency Session of the UN General Assembly to employ the GA's residual powers under Article 12 of the UN Charter, and the Uniting for Peace Resolution 377 (V), to establish a UN mission to monitor a ceasefire and create a protected humanitarian corridor;
- 3. Canada use its authorities under the Export and Import Permits Act and the Special Economic Measures Act, to implement a two-way arms embargo on all military equipment and components to Israel, including through third states, and strengthen enforcement of financial regulations and criminal sanctions to disrupt and freeze any illegal flows of funding to Hamas or other terrorist groups;
- 4. Canada notify Israel of its intention to suspend the Canada-Israel Free Trade Agreement should it continue to fail to meet its International Humanitarian Law obligations and urgently impose trade restrictions on all Israeli exports originating from illegal settlements in the occupied territories;

- Canada give serious consideration to expanding existing regulations under the Special Economic Measures Act to include persons directly involved in or facilitating illegal settlements in the occupied territories;
- Canada reaffirm its respect and support for the key institutions underlying the international rules-based legal order, including the International Court of Justice and the International Criminal Court, and their decisions.

While urgent priority must be given to the cessation of conflict and the protection of civilians we also need to begin building the conditions for a permanent peace. We warmly welcome Minister Anand's participation at the UN High Level International Conference for the Peaceful Settlement of the Question of Palestine where she clearly underlined Canada's longstanding position that the two-state solution is "the only viable path to lasting peace for both Palestinians and Israelis". However, the enormous destruction and death in Gaza combined with the increasingly violent attacks by extremist Israeli settlers against Palestinians in the West Bank, are seriously undermining the viability of any future Palestinian state.

We believe the time has come for Canada to join the 147 nations (soon to be 148 with France) in recognizing the State of Palestine. Recognition will not only reinforce our longstanding commitment to the self-determination of the Palestinian people but also our total rejection of any effort to displace or expel Palestinians. It will create the political space needed to set the stage for a serious bilateral negotiation process and send a clear message to the current Israeli government, which actively opposes a Palestinian state, that it does not have a veto on the recognition of Palestine.

At the same time we must encourage Palestinians to build a new vision for Palestine that eschews terrorism and violence and recognizes Israel's right to exist in peace and security. Canada can play an important role in encouraging and supporting moderate Palestinian leaders to strengthen democratic practices and institutions.

As former diplomats with extensive experience we stand ready to support our government in taking an active and principled role in ending this terrible conflict and humanitarian tragedy and supporting a just and permanent peace.
